












 Expand medical coverage for the uninsured



Influenza Vaccine – HFHS




 Henry Ford Health System (HFHS) administers ~ 100,000 doses per year



 In fall 2004, HFHS provided 12,000 doses to health departments for Wayne, Oakland, and Macomb Counties, and the City of Detroit, to alleviate their shortages
