

## WHAT'S NEW FOR THE 2019–20 FLU SEASON

For the 2019–20 flu season, ([www.cdc.gov/flu/season/flu-season-2019-2020.htm](http://www.cdc.gov/flu/season/flu-season-2019-2020.htm)) ACIP recommends providers administer any licensed, age-appropriate flu vaccine, including inactivated influenza vaccine (IIV), recombinant influenza vaccine (RIV), or live, attenuated, nasal spray influenza vaccine (LAIV4) to everyone age 6 months and older.

Vaccine viruses recommended for inclusion in the 2019–20 U.S. trivalent (three-component) influenza vaccines are:

- A/Brisbane/02/2018 (H1N1)pdm09-like virus (updated)
- A/Kansas/14/2017 (H3N2)-like virus (updated)
- B/Colorado/06/2017-like (Victoria lineage) virus

Quadrivalent (four-component) influenza vaccines will contain these three viruses and an additional influenza B vaccine virus, B/Phuket/3073/2013-like (Yamagata lineage) virus.

## VACCINE INFORMATION STATEMENTS FOR INFLUENZA VACCINES (IIV AND LAIV)

**Vaccine Information Statements (VISs):** Don't forget to give a VIS every time you give a flu shot! There are two updated VISs for use during the upcoming influenza season: live, attenuated influenza vaccine ([www.cdc.gov/vaccines/hcp/vis/vis-statements/flulive.html](http://www.cdc.gov/vaccines/hcp/vis/vis-statements/flulive.html)) and inactivated influenza vaccine ([www.cdc.gov/vaccines/hcp/vis/vis-statements/flu.html](http://www.cdc.gov/vaccines/hcp/vis/vis-statements/flu.html)). Providers are encouraged to begin using the updated VISs immediately, but existing printed stocks may be used until they are gone.

**Prevent Vaccine Administration Errors:** “Know the site and get it right” to prevent vaccine administration errors. As influenza season approaches, now is a great time to remind staff members who administer vaccines how to do it right. CDC has developed tools to share with members of your health care community. These products educate and remind providers about proper influenza vaccine administration techniques to help avoid shoulder injuries and other adverse events.
